To Whom It May Concern:

I am writing to you to notify you that pursuant to the Servicemembers' Civil Relief Act (SCRA), I am terminating the lease of the following described motor vehicle: _____ (ModelYear),

Under the provisions the SCRA, I may terminate my lease of the aforementioned vehicle because after executing the lease I received orders for a permanent change of station or deployment.

I understand that in order to terminate the lease, I am required to do the following:

- (1) Deliver this notice and a copy of my military orders to you or your agent by:
 - a. hand delivery
 - b. recognized courier service
 - c. by U.S. mail in an envelope, postage paid and return receipt requested, addressed to you at the above address or your agent at your agent's designated address
 - d. by any other means you designate: And
- (2) Return the leased vehicle to you or your agent within 15 days after delivery of this notice.

The lease is terminated effective on the date that I have complied with items (1) and (2) above.

I understand that Federal Law requires me to provide you with a signed statement showing the vehicle's mileage at termination of the lease. (Attachment A meets this requirement).

Although I do not have to pay an early termination charge, I understand that I remain liable for the prorated part of my last monthly payment due before the termination date, as well as any past due monthly payments, taxes, summonses and title and registration fees, reasonable charges for excess wear and use and excess mileage, and any other amounts owed under the lease, that have become due and are unpaid at termination in accordance with the terms of my lease.
